I waive and release the Released Parties from all actions, claims, or demands that I,

my heirs, personal representatives, or assigns now have or may have in the future for injuries, damages or death resulting from my participation in any Sun Lakes HOA#1activities.

- 4. <u>Indemnity.</u> I agree to indemnify and hold harmless the Released Parties from any and all loss, liability, claims, damages, costs and expenses (including attorneys' fees) resulting from or relating to, in whole or in part, my participation as a volunteer in construction and other activities of Sun Lakes HOA#1.
- 5. Release of Media Rights. I give to Sun Lakes HOA#1at all right, title and interest I may have in any and all photographic images, video or audio recordings, interviews, and other written, visual or broadcast media made, originated or created by Sun Lakes HOA#1 or its agents or employees during or in connection with Sun Lakes HOA#1 home-building program, including (but not limited to) any royalties, proceeds, or other benefits derived from such materials.
- 6. <u>Declaration.</u> I declare that I am not a registered sex offender nor am I required to register as a sex offender by any state or federal law. I authorize Sun Lakes HOA#1 to check any and all sex offender registries to verify this information.
- 7. Read and Understood. I have carefully read this Agreement and I fully understand its contents. I am aware that this is a legal contract between Sun Lakes HOA#1 and me and that it affects my legal rights. I also understand that by releasing Sun Lakes HOA#1from liability, I am giving up certain rights that I would otherwise have. Arbitration. In the event of any claim, suit or dispute relating to this Agreement or any of the activities or other matters described in the Agreement. I agree that such disputes shall be settled by binding arbitration in the City of Phoenix, in accordance with the rules then prevailing of the American Arbitration Association instead of a trial.
